PAYMENT SCHEDULE AND TERMS OF PAYMENT: All programs are charged by the ANNUAL TUITION of the program. There are two payment options available: •You can pay in full by check and receive a 3% discount off the total. •You can pay a 20% down payment at the time of Registration and then the balance can be paid without interest in 8 equal monthly installment payments beginning in August 2024 and ending in March 2025.						
With the monthly installment option, payments are due on the 1 st of each month through and including March 2024. Payments not received by the 5 th of the month are delinquent and subject to a 10% late fee. If the payment including late fee is not received by the 15 th of the month, the child's enrollment can be terminated.						
You may pay the balance to your account in full by July 1, 2024, by check and receive a 3% discount.
