**THE FOLLOWING IS DUE AT THE TIME OF REGISTRATION: \$225 Registration Fee for the first child (\$125 for each sibling attending the same school year), down-payment equal to 20% of the annual tuition of your child's program and a completed registration packet. (Material Fees included)**

#### PAYMENT SCHEDULE AND TERMS OF PAYMENT:

All programs are charged by the ANNUAL TUITION of the program via brightwheel billing.

20% down payment plus registration fee will be invoiced through brightwheel billing at the time of Registration and the balance will be invoiced, without interest, in 8 equal monthly installments beginning in August 2026 and ending in March 2027.

Monthly installments are invoiced on the 1<sup>st</sup> of each month through and including March 2027. Payments not received by the 5<sup>th</sup> of the month are delinquent and subject to a 10% late fee. If the payment including late fee is not received by the 15<sup>th</sup> of the month, the child's enrollment can be terminated.

#### WITHDRAWAL AND REFUND POLICY:

1. The registration fees are non-refundable.
2. With written notice on or before 12:00 noon on April 2, 2026, 50% of the down payment is refunded.
3. No refunds will be issued after 12:00 noon on April 2, 2026.

#### Disenrollment Policy from September 1<sup>st</sup>, 2026 through March 1<sup>st</sup>, 2027.

1. Newport Center United Methodist Requires a 30-day notice to any schedule changes, including disenrollment.
2. If your account is current, and you withdraw prior to the monthly installment being charged between the months of September and March, 50% of the down payment is applied to the monthly installment and 50% is refunded.

The tuition for all NCUMP programs is an annual fee for the entire school year. The payment schedule is defined above. There will be no pro rata refunds or credits for days that NCUMP is closed for any reason. This applies to health & safety closures or Acts of God.
